NOTICE INVITING BIDS**

**CITY OF RIO VISTA, CALIFORNIA**

Sealed proposals will be received by the City Clerk, City Hall, City of Rio Vista, CA 94571 until 2:00 p.m., on May 27, 2008, at which time they will be publicly opened and read for performing the following described work:

The work consists of construction of new children's play areas, concrete pavement, curbs, concrete seatwalls, chainlink fencing, 7 foot privacy fence, drinking fountain, picnic table, benches, barbeque, planting and automatic irrigation, associated grading and drainage, earthwork, water and utilities work, all as shown on the Drawings and Specifications for Crescent Park, dated April 11, 2008.

The work to be performed shall be completed within ninety (90) calendar days after both parties have signed the contract, and the Contractor shall begin work within ten (10) days after the contract date.

Pursuant to the provisions of Section 1773 of the Labor Code of the State of California, the City of Rio Vista has obtained the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work in this locality for each craft, classification or type of workman needed to execute the contract from the Director of the Department of Industrial Relations. These rates, along with EEO requirements, are on file with the City of Rio Vista. Copies may be obtained at cost at the offices of the City of Rio Vista.

The City of Rio Vista hereby notifies all bidders that it will affirmatively insure that, in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex or national origin in consideration for an award.

For any moneys earned by the Contractor and withheld by the City of Rio Vista to ensure the performance of the contract, the Contractor may, at Contractor's request and expense, substitute securities equivalent to the amount withheld in the form and manner and subject to the conditions provided in Public Contract Code section 22300.

The Contract Documents and Plans and Specifications are available at the office of the City Clerk, City of Rio Vista, Rio Vista, CA 94571, telephone number is (707) 374-6451. A non-refundable deposit of fifty dollars (\$50.00) made payable to the City of Rio Vista will be required.

No bid will be considered unless it is submitted on a proposal form furnished by the City of Rio Vista.

The Contractor must possess a Type "A" Contractor's License or a Type "C-12" Contractor's License.

The Contractor shall furnish two good and sufficient bonds:

1. A faithful performance bond in the amount of one hundred percent (100%) of the contract price; and
2. A labor and materials bond in the amount of one hundred percent (100%) of the contract price.

These bonds will be required at the time the signed contract is returned to the City.

The City Council reserves the right to reject any or all bids and to waive any irregularity in the completion of such forms.
